

THE EXPERIENCE OF CORRUPTION: A GLOBAL ANALYSIS

Corruption is a major problem of governance in countries with most of the world's population and hundreds of millions of people experience its effects by having to pay bribes to get public services. This CSPP study goes beyond looking at the perception of corruption by examining under what circumstances and to what extent citizens pay bribes to obtain health care, education, local government permits and other basic public services. It analyzes multi-national sample surveys of what happens when individuals are in contact with public officials in Africa, Latin America, post-Communist countries and the European Union. The data base covers 125 countries.

The project, which the ESRC is funding until December 2016, draws on the experience of Transparency International's Policy & Research Department and TI's dissemination capacity. In addition, Richard Rose is chairing an advisory Working Group for an EU-funded project on the Impact of Open Data and Transparency of the Italian Research Centre on Security and Crime.
